

Terms and Conditions for Registration

1. Fees and Payment

All fees are quoted in Swiss Francs (CHF) and payable in full in Swiss Francs. We accept credit cards, prepayment by bank transfer and PayPal payments. Registrations become effective only after receipt of payment.

2. Registration Rates

Early registration rates apply for all registrations received before or on April 22, 2012.

Member rates are available for members of ACM, IEEE, IEEE CS, SI, SI-SE, and UZH. Proof of member status is required upon request by ICSE 2012.

Student rates are available only for students who are enrolled in a university as undergraduate, graduate or PhD students. Proof of student status is required upon request by ICSE 2012.

Students who are members of ACM, IEEE, IEEE CS, SI or SI-SE or are enrolled in the University of Zurich are eligible for registering at *student member rates*.

3. Services and Items Included in Registration Fee

3.1 All Events

Registrations for any ICSE 2012 event include

- · Access to all sessions of the event,
- Access to the electronic ICSE 2012 proceedings collection,
- Light continental breakfast, refreshments during breaks, and lunch on the day(s) of the event, except for half-day and 90-minute events. Morning events include breakfast and morning break refreshments only; afternoon events include lunch and afternoon break refreshments only. 90minute events only include break refreshments in the break before or after the event.

3.2 Main Conference

Registrations for the main conference additionally include

- A ticket for the reception on June 6,
- A ticket for the ICSE 2012 banquet on June 7,
- A public transport ticket valid from Mon June 4 to Fri June 8 for unlimited rides within the city limits of Zurich (zone 10).

3.3 Pre- and Post-Conference Events

The following pre- and post-conference events include a dinner:

- Workshops W1 (AST), W2 (MiSE): dinner on Sat June 2,
- Workshop W12 (SEHC): dinner on Mon June 4,
- Workshop W22 (S-Cube): dinner on Tue June 5,
- · Co-located events MSR and ICSSP: dinner on Sat June 2,
- Co-located event SEAMS: dinner on Mon June 4.

Note that all other events don't include a dinner. Tutorial and Technical Briefing registrations also include *access to the electronic notes* of the respective tutorials and technical briefings.

3.4 Day Cards

A day card gives access to all sessions of the respective day and to the electronic ICSE 2012 proceedings collection. It also includes light continental breakfast, refreshments during breaks, and lunch on that day. Any reception or dinner on that day is *not* included.

3.5 Additional Reception and Banquet Tickets

Sales of additional reception and banquet tickets are subject to availability. If more additional tickets are ordered than we can accommodate, tickets will be assigned on a first-registered-first-served basis. If we can't honor already paid ticket requests, the ticket cost will be refunded in full.

4. Discount Codes

Some groups (e.g., student volunteers or corporate donors) will receive discount codes that entitle them to free or reduced-rate registration. Any abuse of discount codes, for example, passing a discount code on to other persons or registering non-entitled persons with a discount code is strictly prohibited. All damage incurred by such abuse will be charged to the abuser.

5. Publication of Photos and Videos

Participants grant ICSE 2012 full and royalty-free permission to publish photos or videos taken at ICSE 2012. If a participant feels harassed by the way she or he is pictured on a photo or in a video published by ICSE 2012, she or he may send a deletion request in writing to the ICSE 2012 General Chair.

6. Cancellations

Cancellations must be made by contacting amiando, the company that handles registrations for ICSE 2012, at *support@amiando.com* or in writing to ICSE 2012.

For cancellations up to April 27, 2012 the total amount paid, minus a processing charge of 6%, will be refunded. Thereafter, the full amount paid will be forfeited.

Substitutions will be accepted only in exceptional cases and only if that case happens after April 27. For making a substitution, send a request in writing to the ICSE 2012 General Chair.

7. Changes to the Conference Program

We have carefully prepared ICSE 2012 and will do our best to run ICSE 2012 as scheduled and published. However, we retain the right to make changes to the program if this should be necessary. Such modifications do not entitle participants to any refunds of participation fees.

If ICSE 2012 has to be cancelled due to reasons that are beyond the power and control of ICSE 2012 organizers (for example, outbreak of infectious diseases or acts of terrorism), participants are entitled to a partial refund of the registration fee only. In this case, the amount remaining after payment of all financial liabilities for ICSE 2012 will be refunded proportionally to the registered participants.

8. Address for Filing Requests

9. Dispute Resolution

All disputes or claims arising from registering for or participating in ICSE 2012 shall be governed by Swiss law and heard by a court of competent jurisdiction in Zurich, Switzerland. Participants consent to jurisdiction in Zurich, Switzerland for that purpose.

10. Validity

Should any of the provisions of these Terms and Conditions or parts thereof be held invalid or unfeasible, such provisions or parts thereof shall be considered severable and such invalidity shall not affect the remainder of the Terms and Conditions.
